PRESIDENT'S LETTER

PRESIDENT'S LETTER APRIL

The show season is progressing and our members have been very successful in showing in All Breed and in Specialty Shows. Congratulations to all of who have participated so far and Best of Luck to all of you who are going to the Potomac.

At our Board meeting we had a discussion about what is in some of our sales contracts and how that may be affected by Federal, State and Local laws. This is intended for discussion purposes only and is not intended to be legal advice. You should get legal advice from your attorney if you require it.

In Georgia, there are numerous laws which affect your contracts and your status as breeders They include but are not limited to the Uniform Commercial Code, the Animal Protection Act and the Federal Department of Agriculture regulations.

The sale of puppies in our state is a sale of goods which is regulated by the provisions of the Uniform Commercial Code where the price is over \$600. There are implied warranties of merchantability and fitness for an intended purpose. These warranties can be disclaimed expressly in writing. For example some people say that the puppies are sold "as is, where is" or "there are no warranties express or implied other than what is expressly contained herein, any implied warranties under the uniform commercial code are expressly excluded."

This is one time where you might want to consult your attorney to prevent some unhappy buyer who says "this dog won't hunt!" from coming back on you. Their claim could involve claims for refund of the purchase price, veterinary expense, other related damages or more.

You may want to examine as well the language you use in your contract to determine whether and or when you are obligated to sell a puppy. If you accept a deposit or if you tell a prospective puppy person you have puppies to sell and they say "fine, I will take one.", you should be clear about when you are obligated to sell, when they are obligated to buy or forfeit their deposit, and under what conditions you can exit the contract by returning the deposit. You may also want to limit the contractual damages you are liable for should you decide not to sell or should they want to return a puppy which they find objectionable. The emotions involved in these contracts are sometimes greater than you would expect.

You may also want to make some determination about how to limit the refund or return of an objectionable puppy. It is very likely that a buyer's expectations are different than yours. In a world where people are used to taking back defective merchandise for a full refund or replacement – no questions asked, you need to be up front and in writing about what you are prepared to guarantee, how that guaranty (warranty) works and what are the limits of liability. If you take deposits you may want to be clear what the deposit is for, how and if it is refundable, and

what it requires you to do. Again you should consult your attorney about the issues of liability in sales contracts. You may be surprised to learn that simply telling someone that they are getting their deposit or purchase price back may not satisfy them. Even if they do not have a claim the cost of defending a claim may exceed the purchase price of the puppy.

Finally the sale of puppies may make you subject to regulation by the State and Federal government. If you have more than 4 bitches capable of being bred or if you sell a puppy to a buyer sight unseen (like over the internet) you may be a "pet dealer" for USDA purposes and subject to Federal regulation. There are certain exceptions but you should be familiar with what they are and how they work. Please consult your attorney for more information. If you board or train or keep dogs for a fee or other compensation; If you sell more than one litter in a calendar year or more than 30 adult dogs you may be subject to regulation under the Georgia animal Protection Act.

This Act has specific requirements including the regulation that no puppies can be sold before they are 8 weeks old among other things. The Georgia Department of Agriculture has the right to come on your property to inspect and check for violations of this act including cleanliness and welfare of you animals. Many counties limit the number of pets you can have and zoning regulations may very well limit where in the county you are allowed to operate. Again there are exceptions to these laws but you should be aware of them.

The point of all of this is that the days of a handshake agreement may be gone if you want to protect yourself from claims by buyers (even people you have known for a while). The sale of puppies that you produce may make you subject to licensing fees, inspections, regulation. The time you spend looking into how to do this correctly with your attorney may well be worth the expense.

If you have questions or would like more information on how animal protection acts and these laws can affect you there are many articles on the web. If you have concerns about you sales agreements you can always call your lawyer. It could save you money in the long run.



AKC'S CGC PROGRAM

Welcome to the AKC's Canine Good Citizen (CGC) Program. Started in 1989, the CGC Program is designed to reward dogs who have good manners at home and in the community. The Canine Good Citizen Program is a two-part program that stresses responsible pet ownership for owners and basic good manners for dogs. All dogs who pass the 10-step CGC test may receive a certificate from the American Kennel Club.

Many dog owners choose Canine Good Citizen training as the first step in training their dogs. The Canine Good Citizen Program lays the foundation for other AKC activities such as obedience, agility, tracking, and performance events. As you work with your dog to teach the CGC skills, you'll discover the many benefits and joys of training your dog. Training will enhance the bond between you and your dog. Dogs who have a solid obedience education are a joy to live with-they respond well to household routines, have good manners in the presence of people and other dogs, and they fully enjoy the company of the owner who took the time to provide training, intellectual stimulation, and a high quality life. We sincerely hope that CGC will be only a beginning for you and your dog and that after passing the CGC test, you'll continue training in obedience, agility, tracking, or performance events.

AKC's Canine Good Citizen (CGC) Program is one of the most rapidly growing programs in the American Kennel Club. There are many exciting applications of this wonderful, entry level that go beyond the testing and certifying of dogs.

Many other countries (including England, Australia, Japan, Hungary, Denmark, Sweden, Canada, and Finland) have developed CGC programs based on the AKC's CGC Program. A CGC Neighborhood Model has been established, police and animal control agencies use CGC for dealing with dog problems in communities, some therapy dog groups use the CGC as a partial screening tool, and some 4-H groups around the country have been using the CGC as a beginning dog training program for children.

A number of specialty (one breed only) clubs give the CGC at their annual national dog show. Dog clubs have discovered that the CGC is an event that allows everyone to go home a winner. Veterinarians have recognized the benefits of well-trained dogs and there are some CGC programs in place in veterinary hospitals. State legislatures began recognizing the CGC program as a means of advocating responsible dog ownership and 34 states now have Canine Good Citizen resolutions.



In a little over one decade, the Canine Good Citizen Program has begun to have an extremely positive impact in many of our communities. This is a program that can help us assure that the dogs we love will always be welcomed and well-respected members of our communities.

All dogs, including both purebred and mixed breed dogs are welcome to participate in the AKC's Canine Good Citizen (CGC) Program. Dogs must be old enough to have received necessary immunizations such as rabies vaccines. Owners will sign the Responsible Dog Owners Pledge attesting to having the dog under the routine care of a veterinarian who will work with the owner to determine an appropriate plan and schedule for vaccines and other health care procedures.

There is no age limit for the CGC test. A dog is never too old to be a good citizen. Puppies who have completed all immunizations and boosters may be tested, however, because we know that behavior and temperament can change over time, when puppies pass the CGC test, owners should have them re-tested as adults.

There are a few exceptions relating to participation in a CGC test. If the CGC test is given at an AKC show, the age requirements for the show apply to CGC also. Further, when the CGC test is administered at an AKC show, the test may be restricted to only dogs entered in the show or to purebred dogs.

Some dogs who are entered in CGC tests will have completed CGC classes or basic obedience classes. Owners who have trained their dogs themselves may also have their dogs tested. Clubs and training programs in almost every city can provide CGC training to owners and dogs who need to learn a few more skills before taking the test.

Puppy Program including purebreds and mixed breeds.

Your puppy will receive the AKC S.T.A.R. Puppy Medal (for display or memento purposes; not suitable as a collar tag). You and your puppy will be listed in the AKC S.T.A.R. Puppy records. In addition, so that you can continue learning, you'll receive our AKC S.T.A.R. Puppy package that includes:
